

ICL Associates and ICL Subunits

ICL plans to build and achieve the Kyoto 2020 Commitment of the World Landslide Community for a long-range global platform for landslide disaster risk reduction towards 2030 and after.

The expected signatory organizations of the Kyoto 2020 Commitment are all of ICL members, IPL-Global Promotion Committee member organizations, ISDR-ICL Sendai Partnerships signatory organizations, ICL supporters and new organizations who are willing to join this Commitment.

New organizations which are willing to join the Kyoto 2020 Commitment are invited to become ICL associates. Where an ICL member organization exists in a given country, an ICL member, an ICL supporter and ICL associates may organize an ICL national group or ICL National Consortium to promote the joint national activities of the Kyoto 2020 Commitment.

ICL may decide upon the definition of ICL associates at the 2017 regular Board meeting to be held at UNESCO Headquarters from 29 November to 1 December 2017.

With that in view, the draft definition which is proposed by ICL secretariat is as indicated hereafter:

1. ICL associates were defined in ICL statutes from 2002-2013 as below.

VI: ASSOCIATES

6. Associates are organizations and individuals who support the objectives of ICL and meet the appropriate financial obligations but do not qualify for Member status.

This category will be revived in the statutes as above. The management of Associates is as follows:

“ICL associates are currently examined in the secretariat to be around 20% of ICL registration fee with journal/token and presentation in IPL symposium and contribution to ICL/IPL activities of Landslides. No voting right in ICL-IPL meeting and no proposal right of IPL Project and WCOEs. They will be invited to ICL national group and national consortium. Candidates are invited to join the discussion on ICL national group and consortium at 2017 ICL-IPL UNESCO Conference on 29 November to 1 December 2017”.

ICL-STC meeting held on 5-6 March 2017 in Kyoto, Japan requested to make a clear definition of right and obligation of ICL associates (or other names). The next page table is the ICL due and rights of different categories of ICL members.

ICL Subunit (tentative):

- Subunit is a unit to promote ICL group activities within ICL members, ICL supporters and ICL associates within an area where those members can closely cooperate for the implementation of IPL projects, WCOE, education and public awareness using the ISDR-ICL Landslide Interactive Teaching Tools (LITT).
- ICL subunit consists of more than three units of ICL members/supporters/associates within an area.
- Example of ICL unit: ICL-Japan, ICL-Mexico, ICL-Sri Lanka, ICL-Slovenia, --- any country, region, province, or area which are convenient for group activities.

ICL will examine ICL unit to promote regional activities in ad hoc and regular Board Meetings in 2017.
