Due date of 2012 ICL membership fee, annual reports of IPL and WCoEs is 30 March 2012.

All IPL project leaders are sure to submit the reports. Those which do not submit activity reports will lose its ongoing status of IPL.

IPL-172, 173, 175 are new, and 2011 reports are not necessary to submit, because it is very short activity period.

3. Please submit the new IPL project proposal by 30 March 2012 to :

The proposal will be examined by the IPL Evaluation Committee and the result will be reported to the 11th BOR at UNESCO and decided.

4. 15 WCoEs were identified in the IPL Global Promotion Committee held on 3 October 2011 at FAO. The activity is still short until 31 December 2011. So the report is not necessary to submit. I will recommend to submit an introductory article of WCoEs in the category of ICL-IPL activities of the Journal *Landslides*.


Other information.

1) The 11th Session of BOR/ICL will be held on 21-23 November 2012 at UNESCO, Paris. All are requested to attend it.

2) ICL could successfully organize the 10th anniversary meeting in Kyoto, 98 members has participated the meeting. We will set up regional and thematic networks of ICL and issue the ICL Strategic plan 2012-2021 which will be informed later after the follow-up and approvals.

Based on the discussion in the ICL 10th anniversary meeting and the Strategic plan, ICL must change for further development and its sustainable management. I request of your cooperation.
